The following issues were found:

- As of the date of completion of the initial audit of 04/05/16, forfeiture of prohibited transactions occurring outside of the records retention period have been waived. As a result, the following prohibited transactions will not be forfeited.
 - Contributions over maximum limit - NCSFAA Inc PAC of \$3,000.00 on 11/06/08, \$1,000.00 on 12/07/09 and \$3,000.00 on 04/01/10 – election period covered from 11/05/08 to 05/04/10.
 - Contributions over maximum limit - Gene Minton of \$2,000.00 on 10/03/11, \$2,000.00 on 12/30/11 and \$1,000.00 on 04/11/12 – election period covered from 11/03/10 to 05/08/12.
 - Contributions over maximum limit - Walter Williams - \$2,000.00 on 06/18/12 and \$4,000.00 on 10/16/12 – election period covered from 05/09/12 to 11/06/12.
 - Business Contribution – Great Living Communities of \$50.00 on 10/04/10.
 - Business Contribution – Guilford Orthopaedics of \$2,800.00 on 01/17/12.
 - Contribution from Non-Registered Federal Committee – EHealth PAC of \$1,000.00 on 10/04/12.
- Contributions appeared to have exceeded contribution limits, and were within the retention schedule when the audit was conducted, and so the following are considered forfeitable. A check for the total of \$5,500.00 has been received.
 - United Furniture Industries PAC - \$2,000.00 on 11/08/12 and \$2,500.00 on 01/15/13 – election period covered from 11/07/12 to 05/06/14.

- W. Trent Ragland - \$1,000.00 on 11/19/12, \$2,000.00 on 04/26/13 and \$2,000.00 on 11/21/13 – election period covered from 11/07/12 to 05/06/14.
- NCSFAA Inc PAC - \$4,000.00 on 01/29/13 and \$5,000.00 on 04/29/14 – election period covered from 11/07/12 to 05/06/14.
- The following contributions were reported as being received during a legislative session. Each PAC in question either has a registered lobbyist, or the parent entity has a registered lobbyist.

In the above instances, the committee provided information that a legislative kick-off event was held on May 11, 2010, the day before the session started. The above contributions were either made at that event or received in the mail prior to the event.

Session 01/26/11 to 06/19/11

Lowes Companies Inc PAC of \$1,000.00 on 01/27/11

NC Assisted Living Assn PAC of \$500.00 on 01/27/11

In the above instances, the committee provided information that a legislative kick-off event was held on January 25, 2011. The above contributions were received on or before the date of the event.

- A number of expense purposes and codes either required additional information to be provided, or changed. These expenses were broken down into four categories:
 - Expense purposes needing a correction to codes or additional detail
 - Expenses paid to American Express – This was Senator Berger's personal credit card. Committee expenses were sometimes incurred on his credit card, and this was then paid directly by the campaign. While nothing was paid incorrectly, this practice has been discontinued.
 - Expenses paid to Berger Law Firm – expenses were paid to the Senator's law firm each month. Additional information was requested as to how the amount was determined. (see attached letter)
 - Expenses to Senator Berger – most of these expenses were for mileage. Committee representatives were able to show all detail related to these mileage reimbursements. Each reimbursement was made based on a mileage record that detailed the event attended or purpose for the travel, and the total miles travelled.
- Occupation information was missing or incomplete for individuals on various reports. In addition, some occupation information was transposed with the job description showing in the employer name, and vice versa. – the committee has made best efforts to secure all missing information. The transposition of

information possibly occurred when the committee changed to a new software and their data was converted.

- A number of 48 Hour Notices were filed with dates that differ from the eventual reported date – the committee advised that they will take additional care when submitting filings to ensure that the dates of receipt listed on its 48 Hour Reports match the receipt date for the same contribution listed on its regular disclosure reports.
- Sum to date totals are calculating on the committee reports for the full election cycle. This causes the contributions to potentially appear to be in excess of the maximum election limit, even when they are not. Correspondence will be sent to the committee's software vendor, giving detail of both Election sum to date totals and Election Cycle to date totals.
- The First Citizens Bank account was created with a code of A. Starting with the 2012 Third Quarter Report, the code appears to have been changed to 1. This gives the appearance that the committee has opened a new account – the committee advises that there has only ever been one account. The code was changed when they started using a new software.
- A number of individual contributors appeared to be potentially duplicated. If names recorded were the same person, these would potentially cause the contribution to exceed limits.
 - Graeme Keith of 2301 Richardson Drive, Charlotte, with an occupation of Real Estate, The Keith Corp and Graeme Keith of 5935 Carnegie Blvd, Charlotte, with an occupation of Real Estate, The Keith Corp. – the committee advises that the first name is Keith Sr., and the second is Keith Jr. No contributions were over limits.
 - O Temple Sloan of 3026 Randolph Drive, Raleigh and O Temple Sloan of 3604 Williamsborough Ct Raleigh, both with an employer name of General Parts International. – The committee advises that the first name is Sloan Jr., and the second is Sloan III. No contributions were over limits.
- The 2014 Second Quarter Report original filing recorded an in-kind contribution of \$5,000.00 from Champ Mitchell on 05/30/14 for fundraiser catering. This entry was subsequently removed on an amended report. This individual made a subsequent contribution of \$5,000.00 on 10/23/14. This, along with the earlier in-kind contribution would have exceeded the contribution limits. – the committee advised that the original in-kind contribution was shown in this manner because they knew the transaction had taken place but had not received the details of either the amount, or the date of purchase, from the individual. The report was subsequently amended to provide the correct date and amount. The corrected date of April 17, 2014 put this in-kind contribution in a different election cycle than the subsequent contribution of \$5,000.00.
- A contribution from the NC Beer & Wine Wholesalers Assn PAC of \$1,000.00, made on 09/04/12, was not recorded on the committee reports as received. –

Committee officers located this contribution as mistakenly deposited to the account of the NC Republican Executive Committee.

- Three PAC contributions were reported in a different amount on the committee reports than the amount reported by the PACs. The following items are in question:

- Southeast Anesthesia Assoc PAC reports giving \$3,000.00 on 04/13/10, the Berger Campaign reports receiving \$2,000.00 on 04/16/10
- Verizon Good Govt Club of NC reports giving \$1,000.00 on 05/04/10, the Berger Campaign reports receiving \$500.00 on 05/11/10
- NC Chiropractic Assn Inc PAC reports giving \$500.00 on 05/07/10, the Berger Campaign reports receiving \$1,000.00 on 05/11/10

Due to the age of these transactions, the committee is not able to secure copies of checks. Reports will not be changed.

- A number of contributions reported as received by the committee are not recorded on the contributing PAC reports.

- Altria Group Inc \$2,500.00 on 05/10/12 – the contribution was recorded as made to NC Republican Executive Committee, but was mistakenly deposited to the committee account.
- Blue Cross Blue Shield of NC PAC \$1,000.00 on 08/30/10 – outside of the records retention period. Nothing was able to be provided by Committee.
- Engineers PAC of NC \$1,000.00 on 01/27/09 - outside of the records retention period. Nothing was able to be provided by Committee.
- Liberty Mutual PAC \$500.00 on 10/04/12 - outside of the records retention period. Nothing was able to be provided by Committee.
- NC Indian American PAC \$1,250.00 on 10/25/10 - outside of the records retention period. Nothing was able to be provided by Committee.

Re: Response to Audit Questions Regarding the Philip E. Berger Committee

Dear Ms. Steffens:

I am writing on behalf of the Philip E. Berger Committee ("Committee") to provide detailed responses to the questions raised in the State Board of Elections ("SBOE") audit review of the Committee's campaign finance disclosure reports. We appreciate your meeting recently with Amy Ellis, the Committee treasurer, and other Committee staff to clarify and narrow the issues involved. Below are the Committee's responses to the questions raised in your April 5, 2016 e-mail to Ms. Ellis. The responses correspond to the numbered items in your e-mail.

1. Contributions identified as potentially exceeding contribution limits

a. NCSFAA Inc. PAC

You identified contributions from this PAC as follows:

\$3,000 on 11/06/2008;
\$1,000 on 12/07/2009; and
\$3,000 on 04/01/2010.

You determined that, for the election period from 11/05/2008 to 05/04/2010, the PAC contributions exceeded the legal limit by \$3,000. After reviewing its records extensively, the Committee believes that the contribution, although reported as received on 11/06/2008, actually arrived at the Committee's post office box prior to 11/05/2008. But the Committee is unable to locate documentation that would prove definitively that the contribution for \$3,000 reported as received on 11/06/2008 was received prior to 11/05/2008 but, without proof, the Committee does not challenge the auditor's finding that the PAC's contributions were \$3,000 more than the \$4,000 contribution limit during that election cycle.

b. Gene Minton

You identified contributions from this donor as follows:

\$2,000 on 10/03/2011;
\$2,000 on 12/30/2011; and
\$1,000 on 04/11/2012.

You determined that, for the election period from 11/03/2010 to 05/08/2012, this donor's contributions exceeded the legal limit by \$1,000. After reviewing its records, the Committee confirmed that it mistakenly accepted \$1,000 in excess of the contribution limit of \$4,000 during that election.

c. Walter Williams and Walter L. Williams

You identified contributions from this donor as follows:

\$2,000 on 06/18/2012; and
\$4,000 on 10/16/2012.

You determined that, for the election period from 05/09/2012 to 11/06/2012, this donor's contributions exceeded the legal limit by \$2,000 if these contributions are from the same person. After further research, the Committee was able to verify that the contributions listed above were from the same individual and that the Committee therefore inadvertently accepted contributions of \$2,000 more than the contribution limit for the election. The Committee has merged these duplicate records in its database to prevent future instances of this situation. The Committee concedes the finding of the auditor regarding this excess contribution.

d. United Furniture Industries PAC

You identified contributions from this PAC as follows:

\$2,000 on 11/08/2012; and
\$2,500 on 01/15/2013.

You determined that, for the election period from 11/07/2012 to 05/06/2014, this PAC's contributions exceeded the legal limit by \$500. After research of its records, the Committee is unable to locate any further documentation that proves definitively that the contribution for \$2,000 reported as received on 11/08/2012 was received on or prior to 11/07/2012, as we suspect. The Committee therefore does not challenge the finding of the auditor with regard to this contribution.

e. W. Trent Ragland

You identified contributions from this donor as follows:

\$1,000 on 11/19/2012;
\$2,000 on 04/26/2013; and
\$2,000 on 11/21/2013.

You determined that, for the election period from 11/07/2012 to 05/06/2014, this PAC's contributions exceeded the legal limit by \$1,000. After research of its records, the Committee is unable to locate further documentation that would contradict the auditor's finding and the Committee therefore does not challenge this finding.

f. NCSFAA Inc. PAC

You identified contributions from this PAC as follows:

\$4,000 on 01/29/2013; and
\$5,000 on 04/29/2014.

You determined that, for the election period from 11/07/2012 to 05/06/2014, this PAC's contributions exceeded the legal limit by \$4,000. After further research of its records, the Committee was able to verify that the contributions above were attributable to the same PAC and that the Committee inadvertently accepted contributions in excess of the contribution limit for the election by \$4,000. To prevent this problem going forward, the Committee has merged its duplicate records for this PAC (NSFAA Inc. PAC and North Carolina State Farm Agents and Associates Inc. PAC) and is in the process of adding SBOE assigned committee identification numbers to all political action committees in its database to prevent a repeat of this mistake. We concede the finding of the auditor that the Committee accepted \$4,000 in excess of the \$5,000 contribution limit from this PAC.

As a result of the foregoing, below is a summary of the net forfeiture due from the Committee:

Attached with this letter is a check from the Committee made payable to the N.C. Civil Penalty and Forfeiture Fund to pay for the forfeiture amount due.

2. Contributions appearing to be either from business entities or non-registered committees.

After research of its records, the Committee is unable to locate any documentation that would show that contributions it received from the following two entities were from registered political committees and therefore does not challenge the auditor's finding that the contributions are from a business entity or a non-registered committee:

- a. Great Living Communities -- \$50 contribution received on 10/04/2010; and
- b. Guilford Orthopaedics -- \$2,800 contribution received on 01/17/2012.

After research of its records, the Committee was able to locate documentation that the contribution from the PAC below was from a federal PAC not registered in North Carolina. The Committee therefore concedes the finding of the auditor that the contribution is from a non-registered committee:

- EHealth PAC, 1615 L Street, NW, Suite 650, Washington DC 20036 - \$1,000 contribution received on 10/04/2012. A copy of the check is attached as Exhibit A.

3. Contribution potentially received during legislative session.

Attached to this letter as Exhibit B is a copy of the invitation to the 5/11/2010 fundraising event that representatives of these political action committees attended in connection with the contribution. The contributions were delivered at the door or received in the mail prior to the event but the Committee does not have documentation for each donor to confirm receipt on those dates. The Committee understands that you will make adjustments to your audit report to reflect the fact that the Committee produced sufficient records during your meeting with Amy Ellis on May 19, 2017 to justify the conclusion that the contributions listed below were received on May 11, 2010 prior to commencement of the 2010 legislative session and that the contributions therefore were not impermissible contributions.

After research of its records, the Committee was able to locate documentation that indicates the contributions from the two PACS below were received prior to the relevant legislative session. See Exhibit C attached hereto. The Committee consents to adjustments by the SBOE to reflect contributions from Lowes Companies Inc. PAC and NC Assisted Living PAC were received on or prior to January 24, 2011 in connection with a January 25, 2011 fundraiser.

4. Expense purposes and codes that either need additional information or a possible change to the code that was provided.

You divided the items included in this part of your audit report into four sections as described below.

a. Expense Purposes

See the Spreadsheet attached hereto as Exhibit D with details provided.

b. American Express Expenses

See the Spreadsheet attached hereto as Exhibit E with details provided. Payments listed on the spreadsheet are reimbursements of expenses incurred by Senator Berger on his personal credit card for Committee expenses that were paid to his personal American Express account rather than to him. This practice was previously discontinued based upon advice from the SBOE staff. The Committee now itemizes reimbursed charges paid for with a credit card.

c. Expenses Paid to the Berger Law Firm

The Committee receives an invoice for \$1,500 each month from The Berger Law Firm P.C. for rent, office supplies, telephone, and secretarial help. It pays the monthly amount pursuant to a written lease and services agreement with The Berger Law Firm. Prior to 09/01/2015, the monthly charge was \$1,200. It is our understanding that the Committee produced sufficient records during your meeting with Amy Ellis on May 19, 2017 to satisfy your questions regarding these expenses. This arrangement has been used by current and former legislators to prevent an impermissible contribution from a corporation and to account for time and resources used by the legislator while he is engaged in campaign activities or legislative

duties at his business office. Attached hereto as Exhibit F is a Committee internal memorandum defining the rationale and calculation of the monthly expense and a list of comparable rents examined by the Committee in determining the amount of monthly rent to pay for partial use of office space at The Berger Law Firm.

d. Philip E. Berger Reimbursement

The Committee receives each month from Senator Berger an invoice that details the mileage (distance and destination) and expenses to be reimbursed by the Committee. It is our understanding that the Committee has produced sufficient records during your meeting with Amy Ellis on May 19, 2017 to satisfy your questions regarding these expenses. See Exhibit G.

5. Missing or Incomplete Occupation Information for Individual Contributors

The Committee requests employer and occupation information in all solicitations. In accordance with updated advice from the SBOE staff, future solicitations will request previous employer or industry for individual contributors submitting "Retired" as their occupation. We are continuing to update and correct our database to ensure that employer and occupation information for individual contributors is listed in the correct field. Attached hereto as Exhibit H is a spreadsheet providing the details requested regarding occupation information.

6. Date discrepancies for contributions listed on both 48 Hour Notices and Report Filings

The Committee will take additional care when submitting filings to ensure that the dates of receipt listed on its 48 Hour Reports match the receipt date for the same contribution listed on its regular disclosure reports.

7. Sum to Date totals on Disclosure Reports.

The Committee has requested that its campaign software vendor, Aristotle International, Inc. ("Aristotle"), revise its disclosure reporting forms to report Election to Date Totals instead of Election Cycle to Date Totals on its disclosure reports, as the SBOE staff has suggested. Aristotle has advised the Committee that they are unable to update their software without official guidance from the SBOE. See e-mail attached as Exhibit I. It is the Committee's understanding that the SBOE will provide updated guidance to vendors in the future.

8. Misclassified Contribution Types

The Committee will update its records and take additional care in future filings to ensure that contribution types are appropriately stated in the pertinent disclosure report section.

9. The First Citizens Bank account code A changed to 1

The Committee has only one bank account at First Citizens Bank. The account reporting code was inadvertently changed from A to 1 starting with the 2012 Third Quarter Report when the Committee began using a new campaign finance reporting software. The Committee will continue to use Code 1 going forward.

10. Contribution from Coca Cola Consolidated PAC listed on 2013 Year End Semi Annual Report

Attached as Exhibit J is a copy of the check received in 2013 from Coca-Cola Consolidated Employee Committee on Good Government.

11. Possible duplicate contributions

The Committee has confirmed that the contributions from the donors listed below were not duplicates:

a. Graeme Keith of 2301 Richardson Dr Charlotte (Real Estate, The Keith Corp) – contributions of \$1,500 received on 04/04/2014 and \$1000 on 02/28/2014. Graeme Keith of 2301 Richardson Drive, Charlotte is Graeme M. Keith, Sr.

Graeme Keith of 5935 Carnegie Boulevard, Charlotte (Real Estate, The Keith Corp) – contribution of \$1,000 received on 04/04/2014. Graeme Keith of 5935 Carnegie Blvd Charlotte is Graeme “Greg” M. Keith, Jr.

b. Temple Sloan of 3026 Randolph Drive, Raleigh – contribution of \$5,000 received on 03/31/2014. Temple Sloan of 3026 Randolph Drive of Raleigh is O. Temple Sloan, Jr.

Temple Sloan of 3604 Williamsborough Court, Raleigh – contributions of \$4,000 received on 12/12/2013 and \$5,000 on 06/10/2014. O. Temple Sloan of 3604 Williamsborough Court of Raleigh is O. Temple Sloan, III.

12. In-Kind Contribution from Champ Mitchell on 2014 Second Quarter Report

An In-Kind Contribution from Champ Mitchell of \$5,000 was reported on the original 2014 Second Quarter Report for catering at a fundraising event. The Committee amended its 2014 Second Quarter Report and in it revised the date and amount of the In-Kind Contribution to

reflect the date of the event (April 17, 2014) for the correct amount of \$699.64, which was verified by the donor, as reflected on Exhibit K.

13. Unreported NC Beer and Wine Wholesalers Association PAC contribution on 09/04/2012 for \$1,000.00

The referenced contribution was located and identified as mistakenly deposited in the North Carolina Republican Executive Committee bank account (Account 2) on 09/11/2012. A copy of the contribution check is attached as Exhibit L.

14. Contribution Amount Discrepancies between PAC and Committee filings

After research of its records, the Committee is unable to locate documentation of the contributions below since the report documentation is beyond the records retention period prescribed by the SBOE.

15. Contributions reported as received by Committee and unreported by PAC Contributor

a. The Committee found record of the contribution described below from Altria Group. The contribution check, which is attached as Exhibit M hereto, was made payable to the North Carolina Republican Senate Committee on 04/26/2017 but mistakenly deposited in the Committee's bank account on 05/10/2012.

- Altria Group Inc. – contribution of \$2,500 received on 05/10/2012.

b. After research of its records, the Committee was able to locate documentation of the following PAC contribution from Anesthesiologists of the Triad PAC but was unable to locate documentation of an 8/30/2010 contribution from Blue Cross Blue Shield of NC PAC or a 1/27/2009 contribution from Engineers PAC of NC since the records related to those two contributions are beyond the records retention period prescribed by the SBOE. A copy of the contribution check from Anesthesiologists of the Triad PAC is attached as Exhibit N.

- Anesthesiologists of the Triad PAC: contribution of \$4,000 received on 01/17/2012.

d. After research of its records, the Committee was not able to locate the PAC check described below, which was reflected on the Committee's 3rd quarter 2012 report. However, the Committee was able to locate a check from Liberty Mutual PAC in the amount of \$500.00 deposited into its bank account on 10/04/2012 but the check, attached hereto as Exhibit O, was dated 6/21/2012 and was made payable to the North Carolina Republican Senate Caucus. The Committee has notified the North Carolina Republican Senate Caucus of the mistaken deposit.

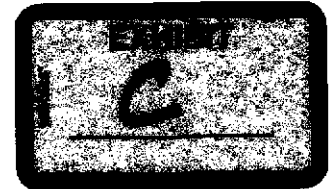
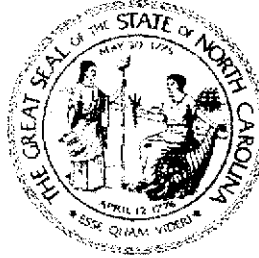

Re: Campaign lease of office space

The Philip E. Berger Committee ("Campaign") leases office space, secretarial support, utilities, and telephone service from The Berger Law Firm, P.C. ("Law Firm") for a monthly charge of \$1,500.

1. The Campaign has rented office space from the Law Firm because it is the most convenient location for Senator Berger to conduct campaign and legislative business when not working on legal matters. The Law Firm is an advantageous place for meetings with constituents and political campaign supporters, staff or vendors. The office is accessible to constituents and others in that it is staffed each day of the work week, it can be found on the Internet, and there is a readily identifiable telephone number to call.

2. The Law Firm has all of the needed office supplies, office space, and staff in place and those items are normally procured by the Law Firm in order to support its law practice. Thus, renting space used part-time by the Campaign is a convenient arrangement for the Law Firm to support.

3. The Law Firm is set up as a professional corporation. It therefore would be illegal for expenses of the Campaign to be paid by corporate funds. Therefore, we have analyzed the monthly fee charged by the Law Firm to make sure that it represents a fair market rental charge.

4. Based upon consultation with real estate agents in Rockingham County and a review of the fees paid by the Law Firm, it would cost in excess of \$3,000 per month to provide a Campaign office in the District with equipment and staff. This estimate is based upon the following estimates for a full-time Campaign office.

5. Based on the fact that the Campaign uses the Law Office space for less than full time, a monthly charge of \$1,500 per month represents a reasonable approximation of fair market rent for the office space and services that are leased to the Campaign. This amount is based on the following:

By leasing space and services, the Campaign is able to have the benefit of a permanent office space with telephone, fax, Internet, staff and meeting space for less than 1/2 the minimum expense of having a separate office. Payments by the Campaign to the Law Firm are taxable to the Law Firm professional corporation. Because the payments are not discounted and reflect the market rate for services provided, the provision of office space and services by the Law Firm does not constitute an impermissible corporate contribution to the Campaign.

We have examined other legislators' campaign reports, at least one of which reflects rental of law firm office space for \$2,000 per month. Several legislators have made similar arrangements with their businesses and the Campaign's lease therefore represents a common practice.

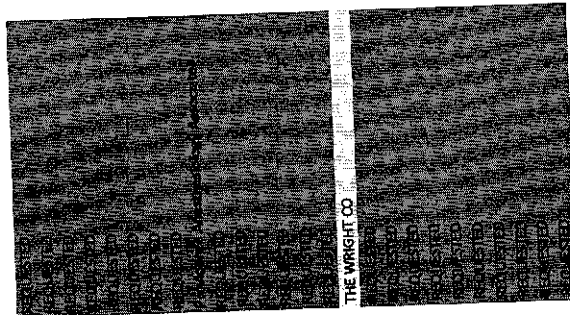

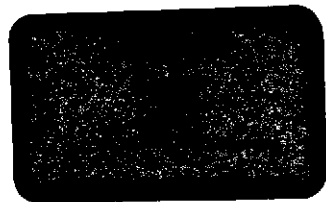

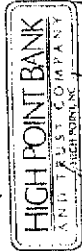
