Forfeiture Agreement (Agreement) between the Harnett County Republican Party and the North Carolina State Board of Elections

On behalf of the Harnett County Republican Party (Committee), I,

Jason T Lemons, in my capacity as Treasurer, agree to the following terms.

The Committee will send an initial payment of \$469.49 due no later than April 5, 2019, for the attached forfeitures. After such payment is made, an additional \$100.00 is due monthly for the next twenty-four (24) months beginning May 15, 2019. Each subsequent monthly payment will also be due on the 15th of the month. The total of all payments is \$2,869.49. If the Committee remains in compliance with this Agreement, the North Carolina State Board of Elections will continue to review Exempt Sales Plans for approval during the life of the Agreement. If any payment is more than 30 days late, the Committee will be considered in violation of this Agreement and is subject to immediate payment of the full outstanding amount. If the balance is not immediately paid, the Committee may also be referred to the North Carolina Attorney General for collection due to its default on the established payment plan.

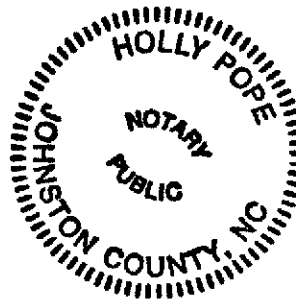
