- The State Board may waive a late penalty if it determines there is good cause for a waiver. A candidate, treasurer, or other authorized agent of a committee may request a waiver on behalf of the committee by completing and mailing, hand delivering or e-mailing a copy of the signed form to: elections@ncsbe.gov, ATTN: Campaign Finance. A separate affidavit form must be completed for each penalty you wish to have waived by the State Board.
- An affidavit is a statement given under oath that its contents are true and accurate. By signing this affidavit form, you swear, under penalty of perjury and other penalties established by North Carolina Law, that the information provided in this affidavit is true, correct, complete, and of your own personal knowledge.
- This affidavit will be disclosed to the public as provided in the North Carolina Public Records Act. (N.C.G.S. § 163A-1451(d))

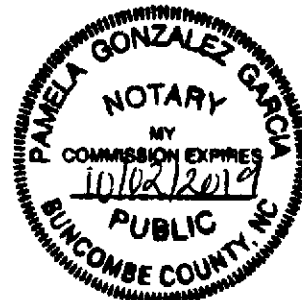

In 2015, Nathan West, the chairman of the Buncombe County Republications asked me if I would help him with a situation. It seemed that the BCGOP was in search of a candidate to run for State Rep 116. Nathan claimed the BCGOP had several candidates, but not one ready to announce and a place holder was needed to go in and file with the Buncombe County Board of Elections on the last day possible for registering. I was told I would only have to be a placeholder for a couple of months max.

Nathan West, the Chairman of the BCGOP told me his wife, Sarah West would be the Treasurer for my committee and that she would handle any further paperwork needed. We never opened a bank account, we never campaigned, and we never raised money. The only money spent was from my personal checking account for the registration fee of \$207.00. I just sat tight until Nathan was ready to announce the candidate. All correspondence went directly to Sarah West.

I resigned the position in June 2016 as Nathan was unable to finalize a candidate. I sent a letter to both John Noce at Buncombe County BOE and to the State BOE. I was assured by Nathan that would be the end of this project. Any other paperwork would be taken care of by the West family.

I received a certified letter on July 10, 2019 and have been working with MS. Harris. I have filled out all missing paperwork and filed all late reports and a certification to close. I have also forwarded a copy of the resignation letter that went to John Noce in Buncombe County.

Please let me know if any additional paperwork is needed. Thank you for your help on this matter.
