Pursuant to N.C.G.S. § 163-278.34(a), if a campaign finance report is not filed within the time required by Chapter 163, Article 22a, then the political committee shall pay a late filing penalty. For reports affecting statewide elections, late filing penalties are assessed at a rate of \$250 per day, not to exceed \$10,000 per report. For reports that do not affect statewide elections, late filing penalties are assessed at a rate of \$50 per day, not to exceed \$500 per report.

The report indicated above was not filed within the time required by Chapter 163, Article 22A. A late filing penalty has been assessed against your committee in the amount identified above.
